- Implement a management system for this policy that involves all the company levels, where it develops and applies indicators that allow for continuous improvement and monitoring.
- Respond to, record, and investigate in a transparent, effective, and timely manner complaints related to our operation impacts and to seek through dialogue the solution and implementation of appropriate compensation when appropriate.
- Promote the child labor prohibition.
